All courses in this catalogue are 1 unit, unless otherwise mentioned. All courses meet on zoom and are open to students at all campuses, unless otherwise mentioned.

Please note that "Core Mediation" is a required course for all students. You may enroll in Core Mediation after completion of all first year required courses. Core Mediation is not part of the Clinical Course Application, so you may register for it on your own, in Populi.

			• <u>Be Prepared</u> : We <i>strongly encourage</i> you to take "Introduction to Community Legal Services" (ICLS) before enrolling in <i>either</i> a clinic or the Mediation Practicum. ICLS uses practice exercises to introduce and build the skills used in these clinics.	
	SLOCL	<ul> <li>Core Mediation (2 units)</li> <li>2 additional clinical units</li> </ul>	• <u>Mediation</u> : The Mediation Practicum course is an advanced class. In this course, students serve as mediators in small cases. You must complete Core Mediation before taking this class. In addition, as noted above, we strongly encourage you to take ICLS before taking this class. Furthermore, if you would like to get more experience with making phone calls and interacting with parties, we strongly encourage you to take another clinic first.

Internships are also an opportunity to demonstrate your talents and skills as a future attorney. Successful interns sometimes even receive job offers! But a mediocre or unsuccessful internship could have the opposite effect. We <i>strongly encourage</i> you to complete other clinical courses within our school before applying for an internship.
